Dear President Obama, Leader Reid, Speaker Pelosi, Leader McConnell and Leader Boehner:

Of the more than 560,000 people in America who die from cancer every year, 300,000 suffer and lose their lives because they lack access to appropriate preventive care and treatment. No one should have to fight for the care they need while also fighting for their life.

The American Cancer Society, the world's largest voluntary health organization, has been working for decades to improve access to health care nationwide. Its advocacy affiliate, the American Cancer Society Cancer Action Network (ACS CAN), has been the leading voice of patients and their families in the health care debate, working with lawmakers from both parties to enact meaningful reform.

Today the Society's National Board of Directors unanimously approved a resolution calling on you and your colleagues - Democrats, Republicans, and Independents - to work together to expeditiously enact legislation that will provide all Americans with improved access to quality, affordable care; enhanced disease prevention and wellness services; and improved quality of life for those who have experienced cancer.

Cancer patients know too well that the current health care system fails those who need it most. A recent poll conducted for ACS CAN found that in the prior year, nearly one-third of cancer patients in current treatment cut pills or skipped doses of medicine, nearly one-quarter delayed a recommended cancer screening or treatment, and one-fifth failed to fill a prescription because of high health care costs.

Americans are suffering and dying needlessly because they lack access to quality, affordable health care. People with cancer and other life-threatening chronic diseases cannot wait for critical improvements to the health care system. They need you to work together to take action now, not later, on meaningful health care reform.
