 - b. What we think the first 100 days will look like in 2025
 - i. Cancer is a non-partisan issue, and thanks to your work with have champions on both sides of the aisle
 - We will be leaning into our Republican relationships and champions (as they have unilateral control of the House, Senate, and Presidency) and developing new champions to make sure we have path forward for priorities
 - ii. We will be playing defense and offense in the next Congress (which we have experience with). And we are adjusting our strategies and tactics to do exactly that.
 - iii. We expect our 100 day priorities will focus on the following 3 priorities:
 - 1. Protecting access to Medicaid
 - a. Expect to be a target for budget reconciliation
 - 2. Increasing cancer research and prevention funding since FY25 funding bill will be kicked into next year
 - 3. Extending the ACA Enhanced Tax Credits
