

## PSA Screening for HIM Act (H.R. 1300/S. 297)

## **Overview**

In 2025, an estimated 313,780 new cases of prostate cancer will be diagnosed in the US and 35,770 men<sup>1</sup> will die from prostate cancer.<sup>2</sup> Some men are at a higher risk of developing prostate cancer than others, including African-American men and men who have a first-degree relative who has been diagnosed with prostate cancer.<sup>3</sup>

world, and their cancer deaths are one of the greatest mortality disparities in oncology.<sup>2</sup> Additionally, having a first-degree relative (father or brother) with prostate cancer more than doubles the risk of developing the disease, the risk is even higher for those with several affected relatives.<sup>4</sup>



Black men have a 70% higher incidence rate compared to White men and approximately **one in six** will be diagnosed with prostate cancer.

## Prostate Cancer Can Be Detected Early

Prostate cancer survival rates increase when it is detected early; however, there has been a recent increase in diagnosis of men with advanced prostate cancer.<sup>2</sup> Screening can help detect prostate cancer at an early stage often before any signs and symptoms are present and before the disease becomes more advanced and more difficult to treat, however cost sharing or out-of-pocket requirements can be a barrier to accessing screening.<sup>5</sup>

The *Prostate-Specific Antigen Screening for High-risk Insured Men (PSA Screening for HIM) Act* (H.R. 1300/S. 297) would give men at high-risk for prostate cancer improved access to prostate cancer screening by requiring

health insurance coverage for evidence-based prostate cancer preventive care and screenings, like the prostate-specific antigen (PSA) test, without cost sharing.

## **ACS CAN Position**

ACS CAN supports the PSA Screening for HIM Act (H.R. 1300/S. 297) because all men at high-risk for prostate cancer who decide to move forward with screening after a discussion with their health care provider about screening and treatment for prostate cancer should have access to screening that is barrier-free without cost sharing.
